1. CASCA Website


The CASCA website (www.casca.ca) was improved by adding details and explanations about the different CASCA membership categories. As a reminder, please note that the website is setup to accept membership payments and donations to CASCATrust via PayPal. Supported by donations from members, CASCATrust funds or helps to fund a number of activities and awards in support of education and astronomical research. 2. By-laws

The by-laws change approved by the membership at the 2010 AGM was submitted to Industry Canada. The amendments received Ministerial approval June 21, 2010. The updated English and French versions have been posted on the CASCA website.

3. CASCA Elections 2011

(professionally engaged in work related to astronomy such as, but not restricted to, instrumentation engineers, teachers, or museum, planetarium or science centre professional staff), Student member (enrolled for at least one academic year in a program of graduate studies in astronomy or astrophysics at a recognized university), and Corporate member. Detailed requirements for each category and application forms are available on the CASCA website (www.casca.ca/Links/Membership.php). The dues may be paid by mailing a check with the application form, or electronically by using the PayPal secure online payment system. Note that members who have let their membership lapse are now required to pay a reinstatement fee when they rejoin. To avoid this reinstatement fee, members who do not wish to remain a CASCA member have to resign in writing, by sending an email to the CASCA Secretary.
