# Treasurer's Report Canadian Astronomical Society Annual General Meeting 2013 University of British Columbia

### General overview

CASCA's financial position at the end of FY 2012 remains highly favourable. The value of our investments has increased approximately 13.5% this FY (7.5% less deposits), quite positive given the recovering market conditions. As proposed in last year's report, \$37.2K was transferred from the operating account to the investments this year (\$5.3K in donations for the Hogg award, \$11.9K in donations for the Executive award, and \$20K in operating surplus). Our main operating account balance was approximately \$50.5K on 31 March.

The projection of the account to the end of FY 2013 includes an updated administrative assistant salary according to a new 3-year contract signed by Susan DiFrancesco and the Board of Directors in April. It is projected that after all programs and commitments are funded, the balance of the general account at the end of FY 2013 should be approximately \$10K lower than the balance at the end of FY 2012.

## Memberships and dues

A total of 451 members (442 in FY 2011) renewed memberships this year (45 by cheque, 5 by US cheque, 377 by Paypal, 21 free first years, 3 dues waived). We currently have 28 joint CAP/CASCA members. Total dues income was \$51.5K, compared to \$50.2K in FY 2011.

Seventy-four members (82 in 2011) are currently in dues arrears. A reminder will be sent out following the AGM.

Due to the particularly low inflation this past year (0.41%), membership dues for 2013 will remain at their 2012 rates.

<u>Dues subscriptions</u>: Starting this year, members will have the option of initiating dues subscriptions for up to 5 years through Paypal. Details will follow later in the summer.

### **CASCATrust**

<u>Donations:</u> Members have generously donated \$2038 to CASCATrust during FY 2012.

<u>Activities:</u> CASCATrust funds were used for a number of activities in FY 2012. The largest expenditure (\$9.6K) was for student and postdoc travel to the AGM. The Plaskett award and associated travel (\$2.9K), the Student Best Paper award (\$1K), the Student Best Oral and Poster Presentation awards (\$0.4K). CASCATrust also contributed \$5K to the Discover the Universe Promoscience initiative.

## **Financial statements**

The financial statements for the RBC bank account are included with this report. Also included is a summary of our investments with Scotia McLeod, and a projection of the operating accounts for FY 2013. The accounts have been audited by the auditor Wilkinson & Co. and the draft reports are available for review by the members.

# Status of investments and report of the Investment Committee

Status of endowments of the awards: All of CASCA's awards with significant monetary prizes carry invested endowments > \$12K. For reference, a \$750 award (e.g. the Hogg) given each 2 years requires an endowment of \$11K-12K (assuming 5% growth and 2% inflation) to pay the prize and maintain the value of the principal. At their 62nd meeting on Monday, the CASCA Board decided to use existing but unallocated invested funds to formally endow the Plaskett award. All of our awards are fully endowed for the current award amounts and timetables, apart from the Executive Award.

<u>Investment committee report:</u> Two new members were appointed to the CASCA Investment Committee following the 2012 AGM, René Racine (ACURA) and Grant Hill (Keck). The Board of Directors extend their sincere thanks for Martin Connors and John Rice for their 4 years of service to this committee.

The CASCA Investment Committee (Grant Hill, Sergey Maschenko, René Racine, Gregg Wade [Chair]) met by telecon on 22 May to discuss the most recent investment reports and advice. These were provided by the Scotia-McLeod investment manager to Wade at a face-to-face meeting on 17 May. The latest report from Scotia-McLeod indicates a net rate or return for fiscal year 2011 of about 7.5%. Our income from dividends and interest during FY 2012 was approximately \$23.7K. We paid \$5.4K in investment management fees. We did not withdraw any cash from our investment account this year.

The evolution of the relative distribution of investment types during the past 3 years is summarised in the following table. The Investment Committee was pleased with the evolution of this distribution, in particular the systematic reduction of cash and cash equivalent holdings and their replacement with investments with better earning potential.

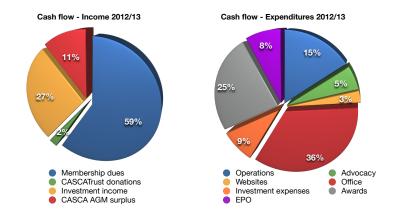

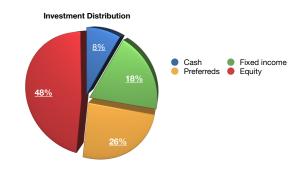
The Investment Committee and Board are very satisfied with the investment performance. They expressed no reservations or concerns regarding the management of CASCA's assets by Scotia-McLeod.

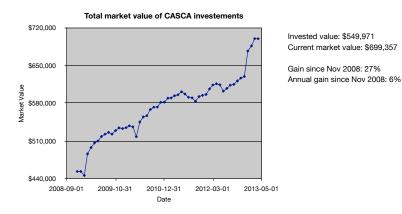
