2) CASCA Membership

CASCA accepts members in the following categories:

- Ordinary member (professionally engaged in research or teaching in astronomy or a related science) **Includes Regular, PDFs, plus Retired**.
- Associate member (professionally engaged in work related to astronomy such as, but not restricted to, instrumentation engineers, teachers, or museum, planetarium or science centre professional staff)
- Graduate Student member (enrolled and continuing in a program of graduate studies in astronomy or astrophysics at a recognized university)
- Undergraduate Student member -- new membership category as of the 2021 AGM (enrolled in a program of undergraduate studies in astronomy, astrophysics, physics, or related science areas at a recognized university who are, or have recently been, engaged in research)
- Corporate member

Detailed requirements for each category and application forms are available on the CASCA website. The **dues are to be paid in the Fall (usually Sept.)**. Note that members who have let their membership lapse are required to pay a reinstatement fee when they rejoin. To avoid the reinstatement fee, those who do not wish to remain a CASCA member must resign in writing, by sending an e-mail message to the CASCA Secretary at <u>CASCA-Secretary@casca.ca</u>. First year graduate students can become members for free for their first year of graduate studies. Also all members of the Graduate Students Committee are exempt from paying fees.

4) CASCA Email Exploder List

Overall, our new sendinblue email exploder system is working well. However, if there is a glitch (e.g. the computer on the receiving end fluctuates or is briefly down and does not receive emails), then all people who normally receive email through their problematic local server are automatically put on the 'black list'. This means that they no longer receive CASCA emails. I have been returning people onto the normal list, as I become aware of the problem. The webmaster has now made a list of all 'blacklisted' people and I have asked the Administrator to provide me with a list of members who are in good standing from that list. When I have received her list, I will 'un-blacklist' these people.

At present, there are 647 people on the CASCA email exploder list. Some of this is because people have registered two different email addresses to ensure that they receive emails at home during the pandemic. However, it is clear that a significant number of people are receiving CASCA email without being members in good standing. Between now and the next Annual General Meeting, I will attempt to rectify this discrepancy.
